

# Privacy Policy E.S.E.V. Zephyr

*Last updated 12th of March 2024*

**Eindhovense Studente eSports Vereniging (E.S.E.V.) Zephyr** is henceforth referred to as “Zephyr” in this document. Zephyr is represented by its current board members, who are the only ones who have access to the personal data of members at any given moment. Zephyr is responsible for the safe and lawful processing of the personal data of its members and users in accordance with the Dutch general data protection regulation.

## Personal data Zephyr stores and processes

If you are a member or attend Zephyr events, Zephyr may store your personal data. Zephyr exclusively stores and processes the personal data that has been provided with consent to be stored and processed (e.g. data provided during sign-up to Zephyr). Zephyr stores and processes the personal data in the following ways:

- **Member Administration:** Zephyr member administration involves using personal data purely within Zephyr for handling the Zephyr WhatsApp communities, Discord server roles, and Zephyr member registration. The personal data stored and processed for this purpose may be:
  - First & Last Name;
  - Phone Number;
  - Email Address;
  - Discord Username;
  - Student Number;
  - Game/Community Interests.
- **General Distribution Statistics:** Zephyr may process some personal data purely for calculating the distribution statistics of such data. The distribution data may be shared with third parties but is completely anonymous. The personal data stored and processed for this purpose may be:
  - Gender;
  - Country code of Phone Number (e.g. +31);
  - Study.
- **Communication of Important Information:** Zephyr signs all members up for the Zephyr Newsletter. Every Newsletter has an unsubscribe link. Zephyr may also process some personal data to communicate important information (e.g. communicating details regarding Zephyr General Member Meetings). The personal data stored and processed for this purpose may be:
  - Email Address.
- **Personal Data related to our Website:** When visiting our website (<https://esevzephyr.nl/>) we may collect the following data.

- Information that allows us to remember you and your preferences in using this website. We use cookies to collect this type of information. Further details on this are available on our Cookie Information page including how to decline/disable cookies.
- Your IP address, which we use to note your interest/visit to our websites.
- Your subscriptions to any newsletters, email updates, etc. made via the website.

### **The sharing of personal data with third parties**

Zephyr does not share any personal data of its members with any third party. Zephyr may however share general distribution statistics with third parties, which are completely anonymous.

### **How long does Zephyr store personal data?**

Personal data is kept for as long as you are a member and thereafter only in the archive for a year after you stop being a Zephyr member. The data is then deleted unless there is a lawful duty that states otherwise. Provided you have given your explicit and informed consent, pictures and videos of events with you in them may reside indefinitely on the member's drive in the photo archive, the Zephyr website, or in any of the Zephyr social media accounts unless you requested these to be deleted.

### **How can you contact us, access and update your information?**

You have the right to access, rectify, restrict, or erase your personal data. You can also object to the processing of your personal data. You may also request that Zephyr transfers the data to you or directly to a third party. Before Zephyr complies with your request, Zephyr may ask you to provide valid evidence of your identity (such as a copy of an ID or passport). Once Zephyr has verified your identity, Zephyr will immediately delete any related documents used for verification of your identity.
